- Fire Safety Act 2021: Expands the FSO to cover any residential building with two or more domestic premises, requiring strict compliance from landlords and building maintenance companies.
- Fire Safety (England) Regulations 2022: Specify regular checks to ensure self-closing devices are functional and all fire doors are in good repair.
- Building Safety Act 2022 and the Golden Thread: Mandates that all fire door-related information be accurately recorded and accessible throughout the building's lifecycle.




